### XII. COMMITTEE OF THE WHOLE CONSIDERATIONS

#### 1. Presentation Of The 2016 Comprehensive Annual Financial Report (CAFR)

City Administrator Marrero reported General Fund revenues outpaced expenditures by \$527,616, increasing the fund balance for the General Fund to \$6.1 million. City Administrator Marrero also noted the Water Fund experienced an operating gain of \$141,000 and operating revenues increased by 20%.

Jody Gauthier, with BKD, thanked the Council for having them back to perform the audit. Gauthier said she appreciated City Administrator Marrero and Consultant Haslett's efforts in assisting with the audit. Kim Marshall, of BKD, provided a brief overview of the FY 2016 audit. Marshall indicated her firm issued a clean unmodified opinion for the FY 2016 audit, which is the highest possible. Marshall noted the City's total assets did not change from last year.

Marshall stated due to the implementation of GASB 67 & 68, the Statement of Net Position now reflects the pension liability of \$13.5 million. Marshall noted the Statement of Activities includes a 6% increase in revenues which is due in part to Water revenues being higher.

Mayor Ragucci thanked the auditors and praised their efforts. The Council concurred to place this on the next consent agenda.

### 2. Renewal Of Property And Casualty Insurance

Assistant to the Mayor and Administrator Sarallo indicated this is part of the annual review of workers compensation and risk management insurance. Assistant to the Mayor and Administrator Sarallo noted Assurance has served as the City's broker for the past five (5) years providing the insurance carriers for property protection for the City's buildings and equipment. Assistant to the Mayor and Administrator Sarallo indicated Assurance recommended the City renew the risk management insurance with Trident. Assistant to the Mayor and Administrator Sarallo added the City switched to Trident last year. Assistant to the Mayor and Administrator Sarallo agrees with the Assurance and recommends

the City maintain the risk management agreement with Trident. Assistant to the Mayor and Administrator Sarallo added the modest increase of \$2,600 really does not reflect a true increase given the City's new Police Station building. Assistant to the Mayor and Administrator Sarallo said the City has a good relationship with Trident and IPRF and it would be advantageous to keep the continuity.

The Council concurred to place this on the next consent agenda.

### 3. Renewal Of Workers Compensation Insurance

Assistant to the Mayor and Administrator Sarallo noted the workers compensation renewal came in \$156 lower than last year's. The Council concurred to place this on the next consent agenda.

4. Approval Of A Video Gaming License – (OBT Pony Express, LLC d/b/a Pony Up) 17W648 22<sup>nd</sup> Street, Oakbrook Terrace, Illinois

The Council concurred to approve this during the reconvened meeting.
