### XI. COMMITTEE OF THE WHOLE CONSIDERATIONS

1. <u>An Ordinance To Increase The Number Of Class "L" Liquor Licenses ( Mike Ditka's Restaurant)</u>

Anthony Ficorilli, Ditka's Managing Partner, addressed the Council and stated the restaurant is requesting their line of wine be sold in a retail capacity. Ficorilli indicated guests often request to purchase the wines offered by Ditka's.

Mayor Ragucci indicated Thomas and Swartz agreed with the additional Class L liquor license. Ragucci noted Devon's Seafood and Grill also has a Class L liquor license.

The Council concurred to place this on the next consent agenda.

2. <u>2016 Property Tax Levy Determination/Police Pension Municipal Compliance Report.</u>

City Administrator Marrero referenced her memorandum and stated increasing last year's levy by the CPI of .7% and capturing new construction of \$2.5 million, the proposed levy comes in at \$953,924. City Administrator Marrero noted this represents a 2% increase over last year's levy, which means a public hearing is not required because the increase is less than 5%.

City Administrator Marrero said the actuary recommended the City contribute \$1,039,771 towards the Police Pension. City Administrator Marrero said in calculating the contribution the actuary used a 6.5% rate of return on investments and a 5% salary assumption. City Administrator Marrero reported the actuary recommendation increased by \$48,000 over last year because the pension fund performance came in lower than the 6.5% rate of return. City Administrator Marrero said the actuarial recommended contribution exceeds the allowable levy by \$85,847, which means the General Fund will have to make-up the difference and possibly transfer in a portion of fund balance. City Administrator Marrero said if we have to transfer-in from the fund balance, the City's fund balance is at a healthy amount of \$6.5 million. City Administrator Marrero said reserving \$86,000 will not impact the balance.

City Administrator Marrero reported beginning this year Public Act 96-1495 authorizes the State to withhold state shared revenue if the City fails to contribute the full actuarial amount. City Administrator Marrero added this Act also requires the City to achieve a 90% funded actuarial liability by 2040. City Administrator Marrero said the City is on target to be 100% funded by 2040. City Administrator

Marrero said the City is currently 48% funded, which is much better than most communities.

Mayor Ragucci said every year the contribution is a little more and fortunately the City has the reserves to finance the difference. The Council concurred to place on the December 13, 2016 consent agenda.

## 3. An Ordinance Amending Section 136 "Drug And Related Offenses".

Ramello said Section 136.1 of the City Code classifies the possession of up to 30 grams of cannabis as a Class A misdemeanor, which includes jail time. Ramello said the State of Illinois recently passed the Cannabis Control Act, which decriminalized the possession of less than 10 grams of cannabis and made it a civil penalty instead of a criminal act. Ramello explained this change made the City Code inconsistent with State law. Ramello said if the City were to retain the current cannabis regulations, the City would be required to send the cannabis to a testing laboratory. Ramello reported the costs associated with the lab tests would exceed the fines assessed.

Ramello said the City Prosecutor recommended the City Code change to match the new State regulations. Ramello said with this change; less than 10 grams of cannabis will be an ordinance violation punishable by a minimum fine of \$100 and a maximum of \$700.

Alderman Esposito indicated the State of Illinois is the 17<sup>th</sup> State to decriminalize cannabis possession. Alderman Esposito asked how this impacts the City. Ramello replied the code change will result in more revenue for the City, because we will no longer be required to send the cannabis to an outside testing laboratory. Ramello said judges will be more willing to impose a fine for a small possession.

The Council concurred to place this on the next consent agenda.

#### XII. COUNCIL MEMBER COMMENTS

Alderman Esposito stated a resident approached him about how some of the new street lights are settling into the ground and causing holes which need to be filled. Alderman Esposito suggested Public Services go around and inspect the residential street lights and patch where needed.

Alderman Esposito said the City is doing a really good job with the rental and property maintenance inspections. Alderman Esposito asked when the City is going to present this information to residents. Mayor Ragucci said information regarding this will be included in the *Terrace Leaves* and a town hall meeting will be held next year

regarding the housing and camera issues. City Administrator Marrero noted this information will be presented at the January 24, 2017 meeting. Alderman Vlach asked about the subdivision security proposals. Mayor Ragucci said staff is currently vetting camera proposals. City Administrator Marrero indicated the City received three (3) proposals for subdivision cameras.
