X. MAYOR RAGUCCI

Ragucci welcomed everyone to the new Council Chambers within the new Police Station. Ragucci stated the turnout for the new Police Station open house was great with about 70-80 people in attendance.

XI. COMMITTEE OF THE WHOLE CONSIDERATIONS

1. Ordinance To Eliminate Lateral Hiring.

Holakovsky stated the lateral hiring program has not been effective since it was instituted three (3) years ago. Holakovsky explained the lateral hire testing had very poor showings and through eliminating the program the City will save approximately \$5,000 in testing fees. Ragucci indicated the City tried lateral hiring, but now the City will continue with the current listing process.

Esposito asked how much it costs to train a new officer. Holakovsky responded about \$3,600. Thomas asked if the Police Department was fully staffed. Holakovsky replied the sworn staff is down by one (1) person and he hopes to fill the vacancy in the next six (6) months.

The Council concurred to place this item on the next consent agenda.

2. Status Report Payout Number One (1): Total Window Treatments.

The Council concurred to place payment number one (1) in the amount of \$20,358.96 to Total Window Treatments on the next consent agenda.

Esposito requested a summary of the Council recommendations regarding the residential inspection program prior to the November 24, 2015 meeting. Esposito asked if there will be a presentation on the current status of the City's residential housing program. Ragucci said the City Administrator is currently working on this. Esposito indicated he is interested to find out what can legally be done within the Council recommendations presented. Ragucci said staff will streamline this before the November 24, 2015 meeting. Greco said he has worked with Dragan on this last week and the purpose is to put all the information out there and go at it.

Vlach asked about the status of the former Remedy restaurant location. Ragucci said Greek Islands plans to host some banquets at the location before the holidays. Vlach also inquired about the status of Pete's Fresh Market expansion. Ragucci said this should take place soon. Swartz indicated he visited the new Specialty's location and thought the 6AM to 6PM Monday through Friday hours was an interesting business plan. Ragucci said the managers are giving this approach a try and the grand opening will take place in two (2) to three (3) weeks.

Ragucci noted Blaze Pizza is opening on Wednesday, October 28, 2015. Ragucci added that Jersey Mike's will be opening soon in the storefront next to Blaze Pizza. Ragucci indicated Curt Hurst will attend the first meeting in December 2015 to discuss the tenant status of the Oakbrook Terrace Square shopping center.

Ragucci read a letter received from York Township thanking the City for their donation of the dais from the Council Chambers formerly located at City Hall.
