#### DETERMINATION THAT AN IN-PERSON MEETING OR A MEETING CONDUCTED UNDER THE OPEN MEETINGS ACT IS NOT PRACTICAL OR PRUDENT BECAUSE OF THE DECLARED DISASTER

**WHEREAS,** on November 13, 2020, the Governor of Illinois issued a Gubernatorial Disaster Proclamation extending the declaration that all counties in the State of Illinois are a disaster area due to the COVID-19 outbreak;

**WHEREAS,** on November 10, 2020, the Governor of Illinois issued Executive Order 2020-70 which limited the maximum number of people physically attending a meeting to ten (10) in parts of Illinois including DuPage County and the City of Oakbrook Terrace ; and

**WHEREAS,** on September 22, 2020, the corporate authorities of the City approved Ordinance No. 20-38, *An Ordinance Extending the State of Emergency in the City of Oakbrook Terrace Due to the Coronavirus (COVID-19) Outbreak* that extended the declaration that a state of emergency and a disaster existed in the City.

**THEREFORE,** by the powers vested in me as the Acting Mayor of the City and pursuant to the November 13, 2020 Gubernatorial Disaster Proclamation, Executive Order 2020-70, Ordinance No. 20-38 extending the state of emergency in the City, and Section 7(e) of the Open Meetings Act (5 ILCS 120/7(e)), I hereby determine that an in-person meeting of the City Council on November 24, 2020, is not practical or prudent because of the declared disaster.

**NOTICE** is hereby given that the November 24, 2020, City Council meeting shall be conducted pursuant to Section 7(e) of the Open Meetings Act and the alternative arrangements for conducting the City Council meeting are as follows:
