City Administrator Ritz provided a summary of the budget meetings held in March and provided updates on some of the line items where adjustments were made. City Administrator Ritz advised that although the process to pay off the Business District 2012B Bond began in April of Fiscal Year 2023 its conclusion and pay off will come during the first month of the new fiscal year of 2024. City Administrator Ritz then related that the Storm Sewer Replacement Project will begin in May or June and is targeted for completion in Fiscal Year 2024. Lastly, City Administrator Ritz informed the City Council and meeting attendees that the Cost of Living Adjustment (COLA) for non-union staff is projected at 3¼% which is also the same, and consistent with the Police Collective Bargaining Agreement (CBA).
