VIII. ITEMS REMOVED FROM THE CONSENT AGENDA

Mayor Esposito asked for a motion to discuss Action Item/Consent Agenda number 5, Resolution No. 23-03: A Resolution To Approve And Authorize The Execution Of An Intergovernmental Agreement By And Between The Illinois Department Of Transportation And The City Of Oakbrook Terrace For Road Improvements To Illinois Route 56. Motion was made by Alderman Barbari and seconded by Alderman Beckwith.

Alderman Greco explained he wanted it to be known that he would abstain from the vote on this item due to a lack of information presented on behalf of the Illinois Department of Transportation (IDOT). Mayor Esposito stated that the presentation given in the packet is different from the updated version of the current scope of work that coincides with the letter provided. Mayor Esposito provided an overview of the letter, which stated that IDOT would be performing Intelligent Transportation Systems (ITS) improvements and upgrades. City Attorney Ramello said that IDOT is bringing the proposal to the City of Oakbrook Terrace to share the associated costs. Alderwoman Fitzgerald and Alderman Beckwith brought up concerns about the possibility of additional expenses. Mayor Esposito directed City Administrator Ritz to contact IDOT for additional information regarding the scope of work and project costs related to the City of Oakbrook Terrace.

Mayor Esposito asked for a motion to table Action Item/Consent Agenda number 5, Resolution No. 23-03: A Resolution To Approve And Authorize The Execution Of An Intergovernmental Agreement By And Between The Illinois Department Of Transportation And The City Of Oakbrook Terrace For Road Improvements To Illinois Route 56. Motion was made by Alderman Rada and seconded by Alderman Greco. Roll call vote was taken.

X. MAYOR ESPOSITO

- Mayor Esposito provided a summary of the 2023 Electronic Recycling and Document Shredding Event.
- 2. Mayor Esposito reminded everyone about the Annual July 4th Celebration.
- 3. Mayor Esposito stated that the Streambank Restoration Project will move to the next phase, but a Town Hall meeting needs to be held to discuss the next landscaping phase. Mayor Esposito stated that the session is targeted for July 22, 2023.
- 4. Mayor Esposito reminded everyone about the 2023 Summer Concert Series.

XI. COMMITTEE OF THE WHOLE CONSIDERATIONS

1. Discussion Of Findings Regarding the Traffic Study Conducted by Christopher B. Burke Engineering, Ltd., On Macarthur Drive and Hodges Road

Mayor Esposito asked City Council to review the traffic study data and asked Dan Lynch from Christopher B. Burke, Ltd., to review the data and provide feedback. Mr. Lynch passed out a memo providing the dates and locations of the data collection along with a statistical analysis of the findings. The memo also compared data collected from a traffic study completed in 2019. In the comparisons, each site had an increase of traffic anywhere from 6% to 9.6%, which were mainly on the cut-through streets. Mayor Esposito felt that one of the sites on MacArthur was not capturing the midpoint of resident concerns.

Alderman Beckwith asked Mr. Lynch what they used as a threshold for speeding over the limit that was considered with the overall statistics in the study. Mr. Lynch stated they used a benchmark of ten (10) miles per hour over the posted speed limit. Alderman Rada commented that people's perception of speed is worse than what it actually is. Alderman Rada asked Mr. Lynch if he felt that Oakbrook Terrace has a problem with speeding, which Mr. Lynch replied and agreed that it's all about perception, but overall, the study shows that speeds are low compared to the overall traffic volume. Alderman Greco reiterated measures the city is taking to mitigate speeding through the residential areas and appreciates the data to provide a better idea of the speeding issue.

2. Discussion on the installation of a Blinkersign Pedestrian Crosswalk Systems on MacArthur Drive and Karban Road.

Mayor Esposito asked City Council to review the pamphlet provided to give the council an overview of what the Blinkersign Pedestrian Crosswalk System is, the statistics regarding pedestrian crosswalk safety, and the overall cost estimate of the system.

City Council agreed that the installation of signs would be beneficial for the safety of our residents and is a proactive way to assist with slowing down traffic. Alderman Beckwith stated that the crosswalk system in the packet is much better than what he was suggesting. Assistant to the City Administrator Raffel related with the traffic in that specific area along with the curve, a more secure system base would be beneficial, but they could also order a sign with a 2x2 pole.

Alderman Rada asked if we could apply for a grant to help offset the costs. Mayor Esposito asked City Administrator to search for any possible grant opportunities, and for Assistant to the City Administrator Raffel to provide other quotes in order to have more information to continue this discussion at a later date.

XII. COUNCIL MEMBER COMMENTS

Alderman Rada commented that the Andy Warhol exhibit at the College of DuPage has seen a great response. Alderman Rada also inquired about the bunting going up in Berkshire with the 4th of July

decorations, and Mayor Esposito replied that the decorations are in the process of being put up all around the city and assured that the buntings will be going up in Berkshire.

Alderman Vlach stated that drivers are ignoring the stop signs at Elder and Stillwell Road and wishes that the police department can monitor the area more.

Alderman Beckwith thanked Flood Brothers and Jerry from ProShred Security for doing a great job and for their assistance at the E-Recycling and Document Shredding Event.

Alderman Greco stated that plumbers point landscaping area looks great but noticed some stumps from the removal of trees are still in need of grinding. Alderman Greco also commented on the excellent job on the sod replacement by Nicor.

Alderman Barbari stated he is thankful for the new sod that Nicor laid down and for the continuous watering that is taking place on the new landscaping.

City Administrator Ritz also stated that the Strategic Planning committee met with Alderwoman Fitzgerald regarding the next phase of the project, and have set a date of July 24th for the Focus Group meetings. This will include our residents, Oakbrook Terrace businesses, Intergovernmental Groups, and city staff.
