X. MAYOR ESPOSITO

- 1. Mayor Esposito thanked all the residents who attended the August 19th Special Council Meeting regarding the Supplemental Landscaping Plan for the Streambank project. He stated there was good discussion and questions regarding the plans and thanked Jedd and Doug from CBBEL for their presentation. Mayor Esposito noted that the landscaping plan is the final phase of project.
- 2. Mayor Esposito stated that his thoughts and prayers go out to Mr. and Mrs. Rusin for the loss of their son Arthur Rusin, who passed away on August 15, 2023.
- 3. Mayor Esposito reminded City Council about the Northern Illinois University Strategic Plan interviews scheduled for Thursday, August 24th, starting at 9:00 a.m.

XI. COMMITTEE OF THE WHOLE CONSIDERATIONS

1. Presentation By the City's Hotel Convention And Visitor's Bureau Commission:

Executive Director Beth Marchetti from the DuPage Convention and Visitors Bureau provided a synopsis of the approved Hotel Convention and Visitors Commission budget. She explained some of the overall budget costs, which included advertising banners, digital campaigns, website maintenance, and DCVB sales initiatives.

2. Spring Road Tributary Restoration Project – Approval Of Pay Request #5 (Invoices 2023-1023) (CBBEL Project 180522):

Mayor Esposito asked the City Council to review the approval of payment request number five (5) for the Spring Road Tributary Restoration Project in the amount of \$35,000.00. Mayor Esposito stated that this included the cost of the remaining tree and brush clearing.

3. Bid Award Recommendation for the Spring Road Tributary Supplemental Landscaping Project, Oakbrook Terrace, IL (CBBEL Project No. 108522)

Mayor Esposito asked the City Council to review the memo prepared by Public Services Director Ward and Christopher B. Burke Engineering, Ltd (CBBEL) representative Jedd Anderson regarding the Spring Road Tributary Supplemental Landscaping Project. Mayor Esposito stated that the Special Council Meeting held on Saturday went well, and we received two (2) requests for proposals.

CBBEL representative Jedd Anderson stated bid packets were opened on Thursday, August 17, and Atrium Landscaping won the bid at \$91,619.00. Mr. Anderson said he has worked with Atrium Landscaping in the past and they have always done reliable work. Public Services Director Ward requested approval to let Atrium Landscaping place the order for the landscaping material to ensure project completion on or before November 3rd. Alderman Greco asked for clarification on watering that was explained by Director Ward. Alderman Beckwith commented on the pricing per unit and felt the contracted price was reasonable.

XII. COUNCIL MEMBER COMMENTS

Alderwoman Fitzgerald stated that she and Alderman Rada had met with the residents at Versailles on the Lakes and passed on some excellent action items to City Administrator Ritz. She further advised that they were trying to set up a meeting with the property manager at Regency Place.

Alderman Barbari questioned the \$9,400 spent on Special Events and what that included.

Alderman Greco wanted to move forward with the annual school art banner and to include all three (3) of the schools.

Alderman Beckwith stated he is pleased with the recent communications from all departments, which is well received. Alderman Beckwith also passed on his condolences to the Rusin Family.

Alderman Rada discussed the 2026 President's Cup and how it will positively impact our hotels and businesses which will benefit the city. Alderman Rada stated that Ward 3 was segmented into four areas, and that he and Alderwoman Fitzgerald are trying to connect with the residents in their Ward.

XIII. CITY ATTORNEY RAMELLO

City Attorney Ramello stated the Intergovernmental Agreement with the Illinois Department of Transportation (IDOT) for maintenance and energy costs was tabled due to shifting the costs to the City of Oakbrook Terrace. According to City Attorney Ramello, IDOT has decided to recover the outstanding costs from the property owner, and not the City.

XV. CITY ADMINISTRATOR RITZ

City Administrator Ritz stated he received and provided updates from Public Services Director Ward for the tentative construction schedule for the storm sewer project. City Administrator Ritz stated that the Executive Leaders had their strategic plan interviews, and MeI from Northern Illinois University (NIU) had nothing but great things to say about the participation from everyone who has participated. He stated that NIU has done a great job throughout the Strategic Planning project. City Administrator Ritz thanked everyone for their time attending the Special Council Meeting and the effort that everyone has put into the Streambank project.
