Vice Chairperson Walberg asked all those who will be speaking this evening to please stand up and be sworn in.

Property Owner Gus Danos and representative George Kourafas were sworn in by Addy Lozano, Building and Zoning / Planning and Zoning Secretary.

Vice Chairperson Walberg asked Building and Zoning Administrator Dragan for her comments.

Building and Zoning Administrator Dragan stated, the landscaping has been done and it looks great. Mr. Danos was more than willing to work with the city and provide a green wall to create a buffer between the residential and commercial properties.

Building and Zoning Administrator Dragan asked Mr. Danos to make a presentation of his request.

Gus Danos stated, I think everyone has seen the property, we removed some of the trees because they were falling in the parking lot or dead. We removed about 23 trees and we added about 150. On the residential side we added another 23 trees. Very soon we will be adding landscaping lights, we power washed the building, and cleaned the windows. We have spent a lot of money to bring it to where it was 30 years ago. I have been in town for about 25 years, and I am very happy to work with the City of Oakbrook Terrace.

Commissioner Freda commented, I remember when the building was first built, and it looks better now.

Commissioner Ventura added, I don't have any questions, I extend my compliments.

Commissioner Jackson asked, how is the occupancy in the building?

Gus Danos answered, occupancy is at about 82%. We might also be moving our office there from Midwest Road.

Commissioner Jackson then asked, can you characterize the tenants you have?

Gus Danos answered, it's a mixture, all good tenants.

Commissioner Cardenas commented, you did a great job.

Commissioner Donoval added, you did a beautiful job.
