Chicago Police Department: Received a background investigation on Kayla Livingston. Secretary took care of request.

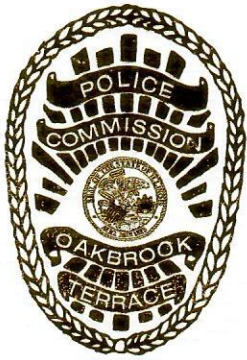
Las Vegas Metropolitan Police Department: Received a background investigation on Trenzel Allen. Secretary took care of request.
