Bills Presented:

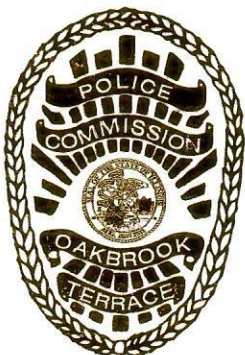
