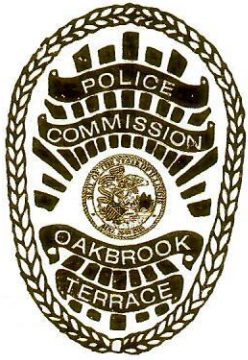
Bills Presented:
