Laptop Quote: Received an email from Tanya Walker on the cost of laptops for

the commissioners. Add to New Business to discuss.

Annette Terry: Received an email letter from former police officer Annette Terry. In her letter she states that Chief Calvello and Deputy Chief Clark were great leaders and always had an open door policy.

Cristian Aldana Morales: Received a forwarded email from Deputy Chief Clark from Morales, he is not interested in coming to Oakbrook Terrace to become a police officer, instead he signed with Wheeling. Board discussed adding a letter of commitment for applicants to sign with our conditional offer of employment.

Email: Received an email from Deputy Chief Clark that the City Council approved raising the number of staffing from 22 to 25 full time sworn officers effective May 1, 2025.

Swearing In: Received an email from Addy Lozano which stated that 3 new officers Lorenzo Marquez, Jose Garcia and Adela Ebibi, would be sworn in on Wednesday, April 9, 2025 at 11:00 a.m. in the City Council room at Oakbrook Terrace Police Department.

Zachary Melchiorre: Received an email from Deputy Chief Clark with a supplemental report for candidate Zachary Melchiorre.

Jose Garcia: Received a forwarded email from Acting Chief Bryant from Jose Garcia waiving seniority rights and is voluntarily doing so.

Deputy Chief Clark: Received an email with preliminary reports on Samatas, Gonzalez and Nunez.

Acting Chief Bryant: Received email for \$38 medical bill for applicant Marasco.

Mayor Paul Esposito: Email received with notes he made from his attendance at the Police Commission March 13, 2025 meeting. Connor Knight: Asked to be on hold until after his college graduation on May 17, 2025.

Swearing In: Lorenzo Marquez and Adela Ebibi were sworn in on Wednesday, April 9, 2025 at 11:00 a.m. by Chairman Valle in the City Council room at Oakbrook Terrace Police Department.

Shanahan motioned that Chairman Valle proceed with three additional backgrounds on next available candidates, seconded by Brown. All in favor.
