Alderman Esposito asked how the City is doing as a whole in relation to the video surveillance. Mayor Ragucci replied last night there were two (2) vehicle thefts in unlocked cars. Mayor Ragucci recommended telling your neighbors to lock their car doors. Alderman Esposito asked if it would be worth sending additional information to the residents considering the low response rate to the video camera surveillance survey. Marrero said a mass mailing can be distributed. Alderman Greco said a mass mailing should be done on items deemed really important by the Council.

Alderman Thomas thanked staff for their efforts on July 4, 2017. Alderman Thomas asked about the maintenance cost for the security cameras. City Administrator Marrero replied typically equipment purchases come with a maintenance agreement. Alderman Vlach said it is up to the Council to decide on how to proceed with the surveillance cameras. Mayor Ragucci agreed if there is not a huge response to the surveillance cameras, then the Council will need to decide on this matter. Alderman Vlach recommended proceeding with the cameras. Alderman Vlach said the July 4th was a great event and noted the tables were too close together. Alderman Swartz commented the July 4th was great.
